I accept that application fees are not refundable, except as covered by VFS's refund policy, and are payable even if a visa is not granted. Also visa bears round stamp and is duly signed by the Visa Officer. Visa is valid from date of issue. It is advisable to make travel arrangements after obtaining appropriate visa.
